

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving the Agreed Upon Procedures Report on the Minors'
First and Second Per Capita)**

RESOLUTION NO. 09-506

1 **WHEREAS, the Tohono O'odham Nation ("Nation") engaged Eide Bailly ("Auditors") to conduct a**
2 **review of the Minors' First and Second Per Capita eligibility determination,**
3 **distributions; and interest calculation; and**

4 **WHEREAS, the Auditors have completed the Agreed Upon Procedures Report for the First and**
5 **Second Per Capita; and**

6 **WHEREAS, the Chairman and Vice-Chairman of the Nation and the Budget & Finance Committee**
7 **have reviewed the Agreed Upon Procedures Report for the First and Second Per Capita.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
9 **approves the Agreed Upon Procedures Report for the First and Second Per Capita.**

10 **BE IT FINALLY RESOLVED that approval is hereby granted to the Chairman and Vice-Chairman of**
11 **the Nation to take the necessary steps to distribute the interest identified from the**
12 **calculation to the members who are owed interest from the first and second per capita**
13 **distributions.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day**
15 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,318.50 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and 277.0[04] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**
