

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2009 Additional Apportionment of Gaming Revenues to Districts)

RESOLUTION NO. 09-507

1 **WHEREAS, pursuant to Resolution 08-490, the Tohono O'odham Legislative Council approved the**
2 **initial apportionment of gaming revenue based on projected allocation of**
3 **\$25,045,627.55; and**

4 **WHEREAS, the Office of the Treasurer has determined the additional gaming revenue amounts**
5 **including interest earned through July 31, 2009; and**

6 **WHEREAS, the Office of the Treasurer presented the additional apportionment amounts to the**
7 **Legislative Budget and Finance Committee as the following:**

25 **approves the FY 2009 Additional Apportionment of gaming revenues and interest**
26 **earned to the Districts as listed in the above table; provided that such amounts are for**
27 **interest accrued through July 31, 2009 and shall only be made available for**
28 **expenditure in accordance with district budgets approved pursuant to Article IX,**
29 **Section 7 of the Constitution of the Tohono O'odham Nation and subject to the**
30 **provision of the Tohono O'odham Code Title 26, Chapter 1, Article 3.**

31 **BE IT FINALLY RESOLVED that the Office of the Treasurer is authorized to transfer the FY 2009**
32 **Additional Apportionment as listed in the above table, subject to the provision of this**
33 **Resolution and the Tohono O'odham Code Title 26, Chapter 1, Article 3.**

34 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day**
35 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,318.50 FOR; -0-**
36 **AGAINST; -0- NOT VOTING; and 277.0[04] ABSENT, pursuant to the powers vested in the Council by**
37 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
38 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
39 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
40 **18, 1934 (48 Stat. 984).**
