

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Adopting Standards of Conduct for Legislative Council Representatives and Alternates)**

**DEFEATED**  
**RESOLUTION NO. 09-510**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**  
2 **Council with the power "to establish rules and procedures to regulate all meetings of**  
3 **the Tohono O'odham Council, standing committees, boards, and special committees."**  
4 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, Legislative Council representatives and alternates ("Council Representatives") are**  
6 **also representatives of the Tohono O'odham Nation and are therefore expected to**  
7 **conduct themselves in a manner which reflects favorably upon the Tohono O'odham**  
8 **and government of the Tohono O'odham Nation; and**

9 **WHEREAS, the Legislative Rules Committee under its general oversight authority has developed**  
10 **the attached "Standards of Conduct for Legislative Council Representatives and**  
11 **Alternates" as dated for reference September 2009 ("Standards of Conduct") to ensure**  
12 **that Council Representatives meet the high standards set forth in the Standards of**  
13 **Conduct; and**

14 **WHEREAS, the Rules Committee has solicited input from Council Representatives on the**  
15 **proposed Standards of Conduct and now recommends its adoption; and**

16 **WHEREAS, it is in the best interest of the Tohono O'odham Nation and its members that the**  
17 **Legislative Council adopt the Standards of Conduct.**

18 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
19 **adopts the "Standards of Conduct for Legislative Council Representatives and**  
20 **Alternates."**

21 **The foregoing Resolution was defeated by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>.**  
22 **Day of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 1,285.6 FOR;**  
23 **1,309.9 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council**  
24 **by Article VI, Section 1 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**
