

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Order No. 09-468, "Setting September 30, 2009 Special Session for
Update on Trust Mismanagement Litigation")**

LEGISLATIVE ORDER NO. 09-513

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**
6 **the authority to "by majority vote, call for a special session" (Legislative Rules of the**
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**


8 **WHEREAS, on August 28, 2009, the Legislative Council passed Legislative Order No. 09-468 and**
9 **thereby set a special session for September 30, 2009 at 1:00 p.m. for an update on trust**
10 **mismanagement litigation; and**

11 **WHEREAS, the Natural Resources Committee is requesting to amend the special session agenda**
12 **for September 30, 2009 to begin at 9:00 a.m. to address the Granite Construction**
13 **Environmental Assessment comments.**

14 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby amends**
15 **Legislative Order No. 09-468 to begin the September 30, 2009 special session at 9:00**
16 **a.m. to address the Granite Construction Environmental Assessment comments.**

17 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 17TH. Day of**
18 **SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 1,999.5 FOR; 421.5**
19 **AGAINST; -0- NOT VOTING; and 174.5[07] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**
