

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY2010 Budget in the amount of \$1,643,104.09 for the Hikiwan District
Administration Operations and the Six Communities of the Hikiwan District in the
amount of \$222,000 for a total of \$1,865,104.09)

RESOLUTION NO. 09-517

1 WHEREAS, the Tohono O'odham Legislative Council by Res. No. 09-425 has apportioned to the
2 Hikiwan District from the FY2009 Gaming Revenues the Equal Distribution amount of
3 \$1,863,072.77 and 20% of the Host Share in the amount of \$39,031.32 to a total of
4 \$1,902,104.09; and

5 WHEREAS, the Hikiwan District Council has presented the attached FY2010 Budget to the Tohono
6 O'odham Legislative Council for approval in the amount of \$1,643,104.09 for District
7 Operations and \$222,000 at \$37,000 each for Six Communities; and

8 WHEREAS, the amount of \$37,000 for the Hikiwan Community will be held in reserve until a
9 budget is submitted and approved by the Hikiwan District Council; and

10 WHEREAS, the Hikiwan District Council Resolution No. HDC-09-139 is also attached approving the
11 FY2010 Budget for the District Administration Operations at \$1,643,104.09 and Six
12 Communities at \$222,000 at \$37,000 each for a total of \$1,865,104.09.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
14 approves the Hikiwan District FY 2010 Budget in the amount of \$1,643,104.09 for
15 Hikiwan District Operations and \$222,000 for the Six Communities for a total budget
16 of \$1,865,104.09.

17 BE IT FURTHER RESOLVED that the \$37,000.00 for the Hikiwan Community will be held in reserve
18 until a budget is submitted and approved by the Hikiwan District Council and the
19 Tohono O'odham Legislative Council.

20 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
21 Chairperson and any designated official to expend and administer the budget as
22 attached, provided that any amendments affecting the funds or funding level shall be
23 submitted for further prior approval by the Tohono O'odham Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH Day
25 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-
26 AGAINST; -0- NOT VOTING; and 174.5[07] ABSENT, pursuant to the powers vested in the Council by
27 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
28 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
30 18, 1934 (48 Stat. 984).
