

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Chukut Kuk District FY 2009 Budget
Amendment/Modification No. 1)

RESOLUTION NO. 09-518

1 **WHEREAS, the Chukut Kuk District Council did meet on August 10, 2009 in San Miguel at which**
2 **a quorum was present and approved amendment/modification to Miguel Community**
3 **FY09 budget to add new language to budget justification for line items 860 and 892 (CK**
4 **Resolution No. 2009-46); and**

5 **WHEREAS, Budget & Finance Committee of the Legislative Council did review the budget**
6 **amendment/modification.**

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
8 **amendment to Miguel Community FY 2009 Budget and Supplement Budget.**

9 **BE IT FURTHER RESOLVED that the Miguel Community budget will be amended to add additional**
10 **language to justification for line items 860 and 892 to read:**

- 11 **860 – Special Activities: “to pay for entertainment such as fiddlers,**
12 **chicken scratch bands, etc.”**
13 **892 – Non Major Capital Equipment: “scanners, computer & other technological**
14 **equipment, etc.”**

15 **BE IT FURTHER RESOLVED that new line items will be added to the Miguel Community FY09 Budget**
16 **and Supplement Budget as follows:**

- 17 **720 – Office Supplies: photo copies for producing pictures for celebration**
18 **plus general office supplies.**
19 **721 – Supplies Other: purchase supplies for fund raisers and special events;**
20 **t-shirts; small appliances such as microwaves.**
21 **722 – Program Supplies: Non-general supplies such as photo copier supplies,**
22 **bottled water, folding chairs, janitorial supplies.**
23 **810 – Professional Services: to hire videographer to produce videos/DVDs, etc.**

24 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
25 **District FY 2009 budget shall be submitted to the Tohono O'odham Legislative Council**
26 **for prior approval.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17TH. Day**
28 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,222.3 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and 373.2[08] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
31 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
