

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Fiscal Year 2010 Budget for Sells District Administration and its  
four Communities in the amount of \$1,863,072.77)**

**RESOLUTION NO. 09-525**

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 09-425 approved the**  
2 **distribution of Gaming Revenues in the amount of \$1,863,072.77 to each of the eleven**  
3 **Districts of the Tohono O'odham Nation; and**

4 **WHEREAS, each of the communities of Sells District prepared and submitted the attached**  
5 **community approved budgets in accordance to their needs; and**

6 **WHEREAS, Sells District Council did review and approve the Sells District Administration Budget**  
7 **and the attached budgets for each of the four communities of the Sells District with**  
8 **Resolution No. SD-83-09 for a total amount of \$1,863,072.77; and**

9 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee and the Tohono**  
10 **O'odham Legislative Council did review and approve Sells District Administration**  
11 **Budget and the budgets for each of the four communities.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves Sells**  
13 **District Fiscal Year 2010 Budget for Administration and it's four communities as**  
14 **submitted in the attached budgets and its justifications to be effective October 1, 2009**  
15 **according to the following:**

21 **for a total budget in the amount of \$1,863,072.77 from Gaming Revenues.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **Sells District Chairperson and any designated District official to expend and**  
24 **administer the budget according to its justification as attached, provided that any**  
25 **modifications/amendments affecting the funds or funding levels of the budget shall**  
26 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup>. Day**  
28 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
31 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
