

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a One Month Continuing Resolution and Amendment #2 Pending
Approval of the Sif-Oidak District FY 2010 Gaming Revenue Budget)

RESOLUTION NO. 09-526

1 WHEREAS, the Sif-Oidak District Council, passed Resolution No. SODC-09-251, "Approving the FY
2 2010 Sif-Oidak District Gaming Revenue Budget in the amount of \$1,863,072.77"; and

3 WHEREAS, the Sif-Oidak District's Fiscal Year 2009 ends on September 30, 2009; and

4 WHEREAS, the FY 2010 Sif-Oidak District Gaming Revenue Budget was reviewed by the Tohono
5 O'odham Legislative Council Budget and Finance Committee on September 23, 2009;
6 and

7 WHEREAS, the Tohono O'odham Legislative Council Budget and Finance Committee
8 recommended that the District enact a continuing resolution pending approval of the
9 Sif-Oidak District FY 2010 Budget; and

10 WHEREAS, there are sufficient funds within the Sif-Oidak District 2009 budget to continue
11 operations.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
13 approve a continuing resolution effective October 1 thru October 31, 2009.

14 BE IT FURTHER RESOLVED that amendment #2, in the amount of \$35,250.00 is incorporated
15 with this continuing resolution as follows:

(618) Contingency	\$18,000.00 (decreased)
(830) Audit	\$17,250.00 (decreased)
(621) Fringe	\$35,250.00 (increased)

19 BE IT FURTHER RESOLVED that there are sufficient funds within the Sif-Oidak District FY 2009
20 Budget to continue operations.

21 BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the
22 attached budget shall be submitted for further prior approval by the Tohono O'Odham
23 Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH Day
25 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
26 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
27 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
28 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
30 18, 1934 (48 Stat. 984).
