

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving San Lucy District Council Request to Continue District Operations**  
**Pending Approval of the FY 2010 Budget)**

**RESOLUTION NO. 09-528**

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the authority to approve,  
2 appropriate, modify and amend expenditures of funds from fiscal resources of the  
3 nation; and

4 WHEREAS, by Resolution No. 08-573 the Tohono O'odham Legislative Council approved the FY  
5 2009 Operational Budget for San Lucy District; and

6 WHEREAS, by Resolution No. SL 09-113-09 the San Lucy District Council is requesting the  
7 Legislative Council to approve the continuance of district operations until the  
8 community members of San Lucy complete their review of the proposed FY 2010  
9 budget; and

10 WHEREAS, the San Lucy District Council have attested that sufficient funds are available to  
11 continue governmental operations and services.

12 NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves  
13 San Lucy District to maintain governmental operational and services at the FY 2009  
14 budget level until the FY 2010 Budget is approved.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day  
16 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-  
17 AGAINST; -0- NOT VOTING; and 198.7[06] ABSENT, pursuant to the powers vested in the Council by  
18 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
19 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
21 18, 1934 (48 Stat. 984).
