

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Carry-over appropriation in the amount of \$52,617.54 for FY 2010
General Support Services - Motor Pool Budget Amendment No. 1)**

RESOLUTION NO. 09-529

1 **WHEREAS, the Tohono O'odham Legislative Council approved a supplemental proposal for each**
2 **of the Nations General Support Services including the Nations Motor Pool (Resolution**
3 **No. 08-073); and**

4 **WHEREAS, Resolution No. 08-073 provides for consideration of approval specific carry over**
5 **amount for the purpose of the initial appropriation; and**

6 **WHEREAS, the Nations Motor Pool submits for review and approval the attached FY 2010 Budget**
7 **Amendment Number 1; and**

8 **WHEREAS, the budget is amended to add line item 750 Major Capital Equipment in the amount**
9 **of \$52,617.54, which is the unexpended amount from the FY 2009 Motor Pool Budget,**
10 **for the purpose of completion of the upgrade of the current fuel system with**
11 **additional fuel sites; and**

12 **WHEREAS, Fiscal Year 2010 Budget Amendment No. 1 for the Nations Motor Pool has been**
13 **reviewed by the Legislative Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council hereby approves**
15 **the carry-over amount of \$52,617.54 that is the unexpended funds from the FY 2009**
16 **Motor Pool Budget to add line item 750 Major Capital Equipment in the amount of**
17 **\$52,617.54 as the FY2010 Motor Pool Budget Amendment No. 1 for the purpose of**
18 **completion of the upgrade of the current fuel system with additional fuel sites.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Official, to wit; the Chairman, Vice-Chairman and any designated official are**
21 **authorized to administer the FY 2010 Motor Pool Budget, provided however, that any**
22 **amendments affecting the funds or funding levels of the budget shall be submitted for**
23 **further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30TH. Day**
25 **of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 198.7[06] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


