

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Governmental Relations Representation Contract with Triadvocates, LLC)**

RESOLUTION NO. 09-532

1 WHEREAS, the Legislative Council is vested with the authority to "consult, negotiate and conclude  
2 agreements and contracts on behalf of the Tohono O'odham Nation with Federal, State  
3 and local governments and other Indian tribes or their departments, agencies, or  
4 political subdivisions, or with private persons or organizations on all matters within  
5 the authority of the Tohono O'odham Council" (Tohono O'odham Constitution, Article  
6 VI, Section 1(f)); and

7 WHEREAS, the Legislative Council approved the FY 2010 Executive Branch Administrative Lobby  
8 Budget, Account No. 01-3002, 811-Lobby, which funds federal and state lobbying  
9 services; and

10 WHEREAS, the Chairman, in consultation with the Appropriations Committee, recommends that  
11 Triadvocates, LLC be retained as a governmental relations consultant for matters  
12 involving State of Arizona legislative, administrative, appropriations, lobbying, and  
13 agency activities, as well as State of Arizona local and municipal governmental  
14 activities, that may affect the Nation in accordance with the attached Governmental  
15 Relations Representation Contract with Triadvocates, LLC ("Contract") for the period  
16 commencing October 1, 2009 and ending March 31, 2010.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:

- 18 1. Approves the Governmental Relations Representation Contract with Triadvocates,  
19 LLC for the period commencing October 1, 2009 and ending March 31, 2010 in  
20 substantially the form attached hereto; provided that the Contract shall be funded  
21 from the FY 2010 Executive Branch Administrative Lobby Budget, Account No. 01-  
22 3002, 811-Lobby.
- 23 2. Authorizes the Chairman of the Nation to execute the Contract.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 30<sup>TH</sup> Day  
25 of SEPTEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,212.30 FOR; -0-  
26 AGAINST; -0- NOT VOTING; and 383.2[08] ABSENT, pursuant to the powers vested in the Council by  
27 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
28 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
29 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
30 Stat. 984).
