

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the San Lucy District FY 2010 Budget)

RESOLUTION NO. 09-600

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with all legislative powers including**
2 **fiscal powers to adopt, approve, amend annual budgets and to authorize**
3 **appropriation of funds; and**

4 **WHEREAS, Resolution Number 09-425 apportioned Gaming Revenues to San Lucy District**
5 **amounting to \$1,863,072.77 and by Resolution Number 09-524 Mining Royalties were**
6 **apportioned into equal shares of \$127,189.58 for districts and said funds will be used**
7 **by districts for budgetary purposes; and**

8 **WHEREAS, the San Lucy District Council has prepared the FY 2010 budget with minor adjustment**
9 **including a 3% COLA modification for district staff and elected officials, increased**
10 **direct assistance to community members and due to the economic conditions of the**
11 **country the district council elected to remain at or near the FY 2009 funding level; and**

12 **WHEREAS, the Budget and Finance Committee has received the district's FY 2010 budget and is**
13 **forwarding it to the Legislative Council for consideration.**

14 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council approves the San**
15 **Lucy District FY 2010 Budget in the amount of \$2,690,556.18.**

24 **BE IT FINALLY RESOLVED that bi-weekly disbursement of P.L. 99-503 funds are wire transferred**
25 **to the San Lucy District General Account at National Bank of Arizona, Gila Bend**
26 **Branch.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH. Day**
28 **of NOVEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
30 **IV, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted by the**
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
