

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the Transfer of Additional Funds in the amount of \$12,000.00 from the**  
**Desert Diamond Savings Account to the Fourth Per Capita Set Aside Account for**  
**6 Additional Eligible Adult Members)**

RESOLUTION NO. 09-602

1 **WHEREAS, on June 28<sup>th</sup>, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono**  
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per**  
3 **capita payments to the Nation's members provided that sufficient gaming revenues**  
4 **are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono O'odham**  
6 **Nation ("Gaming Ordinance") was subsequently amended to authorize per capita**  
7 **distribution payments in accordance with the Initiative (Legislative Council**  
8 **Resolution No. 97-303); and**

9 **WHEREAS, the Legislative Council did adopt the Fourth Per Capita Revenue Allocation Plan per**  
10 **Legislative Council Resolution No. 09-164; and**

11 **WHEREAS, the Secretary of the Department of the Interior did approve the Fourth Per Capita**  
12 **Revenue Allocation Plan on June 15, 2009; and**

13 **WHEREAS, Tohono O'odham Legislative Council Resolution #09-399 authorized establishment**  
14 **of the bank account at Bank of America for the Fourth Per Capita Distribution; and**

15 **WHEREAS, pursuant to Resolution No. 09-428, the initial Master List for certification of eligible**  
16 **adult members for the fourth per capita distribution included 19,141 members; and**

17 **WHEREAS, pursuant to Resolution No. 09-430, the initial authorization to transfer funds was**  
18 **\$38,282,000.00 from the Desert Diamond Savings Account to the Fourth Per Capita Set**  
19 **Aside Account; and**

20 **WHEREAS, the Enrollment Program has identified 6 eligible adult members who were left off the**  
21 **Adult Master Listing for the Fourth Per Capita Payment; and**

22 **WHEREAS, authorization is requested to transfer an additional \$12,000.00 from the Desert**  
23 **Diamond Savings Account to the Fourth Per Capita Set Aside Account for these**  
24 **additional 6 eligible adult members.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
26 **authorizes the Office of the Treasurer to transfer \$12,000.00 from the Desert Diamond**  
27 **Savings Bank Account to the Fourth Per Capita Set Aside Account at Bank of America,**  
28 **pursuant to the terms of the Nation's Revenue Allocation Plan for additional 6 eligible**  
29 **adult members.**



6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
7 Stat. 984).




