**RESOLUTION NO. 09-608**

1 **WHEREAS, the Tohono O'odham Legislative Council approved FY 2010 Management of Health**  
2 **Budget Resolution #09-272; and**

3 **WHEREAS, the Management of Health requested to change the Prevention Grant Manager to the**  
4 **Prevention Division Manager, with a salary increase of \$10,305.16 and increase in**  
5 **fringe benefits of \$3,503.75; and**

6 **WHEREAS, the Management of Health will be decreasing line item Supplies-Other in the amount**  
7 **of \$13,808.91; and**


8 **WHEREAS, the Management of Health reason is the Prevention Division Manager will develop and**  
9 **establish a Prevention program in the Department of Health and Human Services.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the FY2010 Management of Health Budget Amendment #1 which would allow**  
12 **Management of Health to change the Prevention Grant Manager, with a salary of**  
13 **\$50,990.49, to Prevention Division Manager with a salary increase totaling \$61,295.65;**  
14 **an increase in salary of \$10,305.16 and an increase of fringe benefits of \$3,503.75, with**  
15 **a decrease of \$13,808.91 in line item Supplies Other.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes any**  
17 **designated official to expend and administer the budget as attached, provided that**  
18 **any amendments affecting the funds or funding level shall be submitted for further**  
19 **prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup>. Day**  
21 **of NOVEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
22 **AGAINST; 01 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**  
23 **IV, Section 1 (d)(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
