RESOLUTION NO. 09-609

1 **WHEREAS, the Department of Health and Human Services Management of Health Division**
2 **coordinates service provision for its ten divisions; and**

3 **WHEREAS, the Management of Health Division submitted an application to the U.S. Department**
4 **of Health and Human Services Health Resources Service Department for an**
5 **Earmarked grant to purchase equipment to enhance service delivery on May 23, 2009;**
6 **and**

7 **WHEREAS, the Notice of Award was received on September 3, 2009 for a one-year grant, project**
8 **period 09/01/09 through 08/31/10, to purchase telehealth equipment in FY 2010; and**

9 **WHEREAS, the HRSA AHRQ budget of \$93,640.00 is hereby submitted for review and approval by**
10 **the Tohono O'odham Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 12 **1. Accepts the HRSA AHRQ Grant of \$ 93,640.00 as a one year grant.**
- 13 **2. Hereby approves and authorizes expenditures in accordance with the FY 2010**
14 **HRSA Earmark Telehealth grant, and attached budget in the amount of \$93,640.00**
15 **for a one year grant.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairman, and any designated official to expend and administer the budget, as**
18 **attached, provided that any amendments affecting the funds or funding level shall be**
19 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH. Day**
21 **of NOVEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
23 **IV, Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
