

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a \$500.00 Christmas Bonus for Employees of the Executive Branch, Judicial Branch and the Legislative Branch including All Appointed and Elected Officials of All Three Branches)

RESOLUTION NO. 09-613

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **authority to "manage any funds within the exclusive control of the Tohono O'odham**
3 **Nation . . ." (Constitution, Article VI, Section (1)(d)(2)); and**

4 **WHEREAS, the Tohono O'odham Legislative Council has discussed a proposal for a Christmas**
5 **bonus for all employees of the Executive Branch, Judicial Branch and the Legislative**
6 **Branch including all appointed and elected officials of all three branches; and**

7 **WHEREAS, the Legislative Council has discussed the proposal and recommends its passage for the**
8 **best interest of the Nation's employees.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves a**
10 **\$500.00 net check Christmas bonus for employees of the Executive Branch, Judicial**
11 **Branch and the Legislative Branch including all appointed and elected officials of all**
12 **three branches.**

13 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the bonus payments**
14 **will be issued on payroll date of December 11, 2009 for all employees and is exclusive**
15 **to only those who are employed on December 11, 2009.**

16 **BE IT FINALLY BE RESOLVED that the \$500.00 net check Christmas bonus is hereby appropriated**
17 **from the Fiscal Year 2010 General Fund Surplus for a total amount of \$1,006,966.80 in**
18 **accordance with the Christmas Bonus Calculation Option A, which is incorporated by**
19 **this reference.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
21 **of NOVEMBER, 2009 at a meeting at which a quorum was present with a vote of 1,409.0 FOR;**
22 **1,186.50 AGAINST; -01- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
