

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Pisinemo District FY 2010 Mining Royalty Budget)

RESOLUTION NO. 09-624

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 09-524 approved FY 2010 District**
2 **Allocation and Apportionment of Mining Royalties to Districts by equal distributions;**
3 **and**

4 **WHEREAS, a draft FY 2010 budget in the amount of \$127,189.50 was presented to the Pisinemo**
5 **District Council for review, comment and recommendations; and**

6 **WHEREAS, the draft FY 2010 budget was also taken out to the communities of San Simon,**
7 **Pisinemo, Santa Cruz, Kupk and Dirtburn for review and comments and then brought**
8 **back to the Pisinemo District Council for action; and**

9 **WHEREAS, the respective communities and Pisinemo District Council have approved the FY 2010**
10 **District Mining Royalty Budget to be distributed as follows:**

11	Salaries	\$ 31,200.00
12	Fringe Benefits	\$ 8,736.00
13	Insurance	\$ 804.00
14	District Operations	<u>\$ 86,449.58</u>
15	Total	\$ 127,189.58

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **approves the Pisinemo District FY 2010 Mining Royalty Budget in the amount of**
18 **\$127,189.58.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairman,**
20 **Vice Chairman and any designated official are authorized to expend the budget,**
21 **provided however, that any amendments affecting the funds or funding levels of the**
22 **budget shall be submitted for further prior approval.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
24 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,209.70 FOR; 187.10**
25 **AGAINST; -0-NOT VOTING; and 198.70[05] ABSENT, pursuant to the powers vested in the Council by**
26 **Article IV, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted by**
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


