

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 09-613 "Approving a \$500.00 Christmas Bonus for Employees**  
**of the Executive Branch, Judicial Branch and the Legislative Branch including All**  
**Appointed and Elected Officials of All Three Branches" to Increase the Amount**  
**Appropriated from Fiscal Year 2010 General Fund Surplus)**

RESOLUTION NO. 09-626

1 WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation" (Constitution of the  
3 Tohono O'odham Nation, Article VI, Section 1(d)(2)); and

4 WHEREAS, pursuant to Resolution No. 09-613, the Nation previously appropriated Fiscal Year  
5 2010 General Fund Surplus in the amount of \$1,006,966.80 for a Christmas Bonus; and

6 WHEREAS, the amount increased due to actual employees for the December 11, 2009 payroll  
7 including new employees hired during the week of December 7, 2009.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
9 amends Resolution No. 09-613 to increase the amount appropriated from Fiscal Year  
10 2010 General Fund Surplus by \$38,530.82 thereby increasing the total amount  
11 appropriated for the Christmas bonus from \$1,006,966.80 to \$1,045,497.62.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day  
13 of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 1,445.70 FOR; 975.30  
14 AGAINST; 174.50 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
15 Article IV, Section 1 (d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).


