

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #1 to the Tohono O'odham Nation Fire Department Fiscal
Year 2010 Carry Over Budget)

RESOLUTION NO. 09-631

1 **WHEREAS, the Tohono O'odham Nation Department of Public Safety Fire Department has**
2 **deemed it critical and necessary to increase Fire Protection services to the Tohono**
3 **O'odham Nation, particularly the new Desert Diamond Casino/Hotel; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved a supplemental request of**
5 **\$4,055,700.00 for the construction of a Fire/Police substation, to fund fire apparatus**
6 **and for other costs associated with additional staff; and**

7 **WHEREAS, the actual construction of the proposed Fire/Police substation will not begin until**
8 **Fiscal Year 2010; and**

9 **WHEREAS, the construction of fire apparatus funded in Fiscal Year 2008 will begin in Fiscal Year**
10 **2010; and**

11 **WHEREAS, other costs associated with the funded capital projects remain; and**

12 **WHEREAS, the Tohono O'odham Legislative Council approved a \$2,922,500.00 carry over budget**
13 **for the Fire Department for Fiscal Year 2010; and**

14 **WHEREAS, \$1,160,197.95 remains unexpended in fiscal Year 2009 funding.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
16 **Amendment #1 to the Fire Department Fiscal Year 2010 Carry Over Budget in the**
17 **amount of \$1,160,971.95 in unexpended Fiscal Year 2009 funds to bring the total**
18 **amended Fiscal Year 2010 budget of \$2,922,500.00 to a total of \$4,083,471.95 in**
19 **accordance with the budget attached hereto.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the**
21 **Chairman and any designated official to expend and administer the budget as**
22 **attached, provided that any amendments affecting the funds or funding level shall be**
23 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
25 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
27 **IV, Section 1 (c)(1)(d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
