

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2010 Attorney Contract for Lawrence O. Boswell to Serve as
Conflict Attorney)

RESOLUTION NO. 09-633

1 WHEREAS, there is a need for attorneys to handle conflicts which the Tohono O'odham Advocate
2 Program is not ethically allowed to handle in regards to the increasing needs of tribal
3 members for legal representation in civil and criminal matters; and

4 WHEREAS, the Advocate Program wishes to contract with Lawrence O. Boswell to represent
5 clients with conflicts who cannot be represented by the Nation's Advocate Program
6 due to the program's conflict of interest; and

7 WHEREAS, the Advocate Program has presented a contract for Lawrence O. Boswell which
8 confirms the terms and conditions related to his services, a copy of which is attached
9 hereto; and

10 WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council
11 of a Conflict Attorney Contract with Lawrence O. Boswell on such terms.


12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
13 Conflict Attorney Contract for Lawrence O. Boswell in substantially the form attached
14 hereto in an amount not to exceed \$71,000.00.

15 BE IT FURTHER RESOLVED that the Contract shall be effective as of December 1, 2009 thru
16 September 30, 2010.

17 BE IT FINALLY RESOLVED that the funding source for the Conflict Attorney Contract for Lawrence
18 O. Boswell shall be provided under the operating budget of the Tohono O'odham
19 Advocate Program for fiscal year 2010.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day
21 of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,209.70 FOR; -0-
22 AGAINST; 198.70 NOT VOTING; and 187.10[04] ABSENT, pursuant to the powers vested in the Council
23 by Article VI, Section 2 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the
24 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat. 984).
