

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY2010 Attorney Contract for Belinda BreMiller to Serve as Conflict Attorney)**

**RESOLUTION NO. 09-634**

1 **WHEREAS, there is a need for attorneys to handle conflicts which the Tohono O'odham Advocate**  
2 **Program is not ethically allowed to handle in regards to the increasing needs of tribal**  
3 **members for legal representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to contract with Belinda BreMiller to represent clients**  
5 **with conflicts who cannot be represented by the Nation's Advocate Program due to the**  
6 **program's conflict of interest; and**

7 **WHEREAS, the Advocate Program has presented a contract for Belinda BreMiller which confirms**  
8 **the terms and conditions related to his services, a copy of which is attached hereto;**  
9 **and**

10 **WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council**  
11 **of a Conflict Attorney Contract with Belinda BreMiller on such terms.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
13 **Conflict Attorney Contract for Belinda BreMiller in substantially the form attached**  
14 **hereto in an amount not to exceed \$45,000.00**

15 **BE IT FURTHER RESOLVED that the Contract shall be effective as of October 1, 2009 and shall end**  
16 **September 30, 2010.**

17 **BE IT FINALLY RESOLVED that the funding source for the Conflict Attorney Contract for Belinda**  
18 **BreMiller shall be provided under the operating budget of the Tohono O'odham**  
19 **Advocate Program for fiscal year 2010.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day**  
21 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and 187.10[04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 2 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
