

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting and Approving the Arizona Department of Homeland Security, 2008 State**  
**Homeland Security Grant for \$60,000.00, Grant #444411-02)**

**RESOLUTION NO. 09-635**

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to counties,**  
2 **through their respective states, to fund equipment purchases and training by**  
3 **departments that provide public safety services within their respective jurisdictions;**  
4 **and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**  
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**  
8 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**  
9 **Department of Homeland Security, Federal Emergency Management Agency,**  
10 **Homeland Security Grant Program on a reimbursement basis to finance the**  
11 **Homeland Security Mobile Data Capabilities Enhancement; and**

12 **WHEREAS, the Letter of Offer and Acceptance was approved in the form attached hereto by the**  
13 **Tohono O'odham Legislative Council through Resolution 09-256 signed by the**  
14 **Chairman; and**

15 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the Arizona Department**  
16 **of Homeland Security in the amount of \$60,000.00 as part of the 2008 State Homeland**  
17 **Security Program Grant No. 444411-02 for this project; and**

18 **WHEREAS, the 2008 State Homeland Security Program Grant No. 444411-02 award of \$60,000.00**  
19 **has been reviewed by the Office Grants & Contracts, Executive Office, Domestic Affairs**  
20 **Committee and Budget & Finance Committee, of which all recommend acceptance of**  
21 **the grant award by the Legislative Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**  
23 **approves the 2008 State Homeland Security Grant No. 444411-02 award of \$60,000.00**  
24 **on a reimbursement basis from the Tohono O'odham Nation General Fund for the**  
25 **Enhance Mobile Data Capabilities needed for enhancing the Tohono O'odham Nation**  
26 **Law Enforcement and further waives any additional indirect cost to administer this**  
27 **grant.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation, Law Enforcement is authorized to**  
29 **expend funds from this grant in the amount of \$60,000.00 in accordance with the terms**  
30 **of the 2008 State Homeland Security Program Grant No. 444411-02 from October 1,**  
31 **2009 to December 31, 2009.**

3 **authorized to negotiate and execute the grant, provided however, that any**  
4 **amendments affecting the funding or funding levels of the grant shall be submitted**  
5 **for further prior approval.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day**  
7 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
8 **AGAINST; -0-NOT VOTING; and 187.10[04] ABSENT, pursuant to the powers vested in the Council by**  
9 **Article VI, Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
10 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
12 **Stat. 984).**
