1 **WHEREAS, the Legislative Council held a meeting on December 09, 2009 with a quorum Present;**
2 **and**

3 **WHEREAS, the Executive Branch Fiscal Year 2010 budget \$1,266,668.27 for the period beginning**
4 **October 1, 2009 ending September 30, 2010 has been presented to the Legislative**
5 **Council both in summary as well as detail description; and**

6 **WHEREAS, the Adult Protective Service Division FY 2010 Budget Amendment #1 has been**
7 **prepared to increase and add Occasional Appointments, Fringe Benefits, Utilities, add**
8 **Uniforms, and Lease/Rental line items, the total increase for line items is \$79,928.93;**
9 **and**

10 **WHEREAS, the budget amendment does increase the budget amount for Fiscal Year 2010 base**
11 **budget of \$1,266,668.27 approved by the Tohono O'odham Nation Legislative Council**
12 **for the Adult Protective Services Division.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
14 **the Fiscal Year 2010 Budget Amendment #1 submitted for Adult Protective Service.**

15 **1. The funds from the increase line item to be utilized in the Occasional**
16 **Appointment and Lease/Rental, Fringe Benefits, Utilities, and Uniforms line**
17 **items. Approves and authorizes expenditures for Adult Protective Services**
18 **Division in the amount of \$79,928.93 to be allocated from Surplus Funding.**

19 **2. The amount needed to fund the Adult Protective Services Division for Fiscal Year**
20 **2010 will become the base budget for Fiscal Year 2011.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget, as**
23 **attached, provided that any amendments affecting the funds of funding levels of the**
24 **budget shall be submitted for further prior approval by the Tohono O'odham**
25 **Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
27 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**
28 **AGAINST; -01-NOT VOTING; and 187.10[05] ABSENT, pursuant to the powers vested in the Council**
29 **by Article VI, Section 1 (d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the**
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
