

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Xavier District's FY10 Budget Amendment #1 to add Mining and
Gaming Interest of \$31,124.22)**

RESOLUTION NO. 09-645

1 **WHEREAS, the San Xavier District Council has reviewed the projected expenditures for the fiscal**
2 **year ending on September 30, 2010 and has determined that the budget components**
3 **are essential to meeting the needs of the San Xavier District Community; and**

4 **WHEREAS, the District has received statements dated July 31, 2009 from the Treasurer's Office of**
5 **the Tohono O'odham Nation informing the District of 1) the funds accumulated from**
6 **the interest on the gaming funds; and 2) available mining revenues; and**

7 **WHEREAS, the proposed budget originally included \$25,672.28 of Gaming Fund Interest Income**
8 **and an additional amount of \$8,451.94 in Mining Revenues to assist the District in**
9 **meeting the budgeted expenditures; and**

10 **WHEREAS, during the original budget approval process the District was informed by the Tohono**
11 **O'odham Legislative Council's (TOLC) Budget & Finance Committee that these funds**
12 **were not available to meet the budgeted expenditures at that time; and**

13 **WHEREAS, the Tohono O'odham Legislative Council has made the San Xavier District aware that**
14 **Gaming Funds Interest Income and Mining Revenues are now available for the**
15 **District's use; and**

16 **WHEREAS, the San Xavier District Council (SXCD Resolution #10-09-08) approved its FY10 budget**
17 **amendment by incorporating the above referenced Gaming Funds Interest Income**
18 **and Mining Revenues totaling \$34,124.22 as part of its FY10 budget.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
20 **the San Xavier District's FY10 budget amendment to include the interest on the**
21 **gaming funds in the amount of \$25,672.28 and mine revenues in the amount of**
22 **\$8,451.94 totaling \$34,124.22 to be added to the District's FY10 budget, replacing the**
23 **District's Reserves (Savings) by this same amount and not affecting the grant total**
24 **amount of \$7,450,897.69 to meet the expenditures previously approved in its FY10**
25 **budget.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
27 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and 187.10[03] ABSENT, pursuant to the powers vested in the Council**
29 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'Odham Nation, adopted**
30 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
