

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Rescinding Resolution No. 82-88, "Adoption of the Natural Resources Committee's**  
**Plan of Operation")**

**RESOLUTION NO. 09-647**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Legislative Council,**  
3 **standing committees, boards, and special committees pursuant to the Constitution**  
4 **of the Tohono O'odham Nation, Article VI, Section 1(a) and (b); and**

5 **WHEREAS, in 1988 the Legislative Council adopted a Plan of Operation for the Natural Resources**  
6 **Committee pursuant to Resolution No. 82-88, "Adoption of the Natural Resources**  
7 **Committee's Plan of Operation"; and**

8 **WHEREAS, the Natural Resources Committee has drafted amendments to update its Plan of**  
9 **Operation; and**

10 **WHEREAS, the Rules Committee has reviewed the Natural Resources Committee Plan of**  
11 **Operations amendments and recommends its adoption; and**

12 **WHEREAS, because the Natural Resources Committee's updated Plan of Operation will replace**  
13 **the plan adopted pursuant to Resolution No. 82-88, it is necessary to rescind**  
14 **Resolution No. 82-88.**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
16 **rescinds Resolution No. 82-88, "Adoption of the Natural Resources Committee's Plan**  
17 **of Operation."**


18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>. Day**  
19 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0-**  
20 **AGAINST; 01 NOT VOTING; and 187.10[03] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1 (a) and (b) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**
