

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Overriding Veto of Resolution No. 09-630, "Approving Alternative Council Salary Adjustment")**

FAILED
RESOLUTION NO. 09-649

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **broad legislative and fiscal powers, including the power to manage, appropriate, and**
3 **authorize the expenditure of any funds within the exclusive control of the Tohono**
4 **O'odham Nation (Constitution of the Tohono O'odham Nation, Article VI, Section**
5 **1(d)(2)); and**

6 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council provide that**
7 **"Legislative Council representatives, including the legislative officers, shall be**
8 **compensated at annual salaries to be established by the Legislative Council.**
9 **Representatives' salaries shall be comparable to other officials of the Nation and**
10 **shall not be decreased during a representative's term of office..." (Legislative Rules,**
11 **Article X, Section 1); and**

12 **WHEREAS, on December 7, 2009 the Legislative Council approved Resolution No. 09-630,**
13 **"Approving Alternative Council Salary Adjustment," which was subsequently vetoed**
14 **by the Nation's Chairman; and**

15 **WHEREAS, pursuant to Article VII, Section 5 of the Constitution of the Tohono O'odham Nation,**
16 **the Council may override a veto "by a majority of two-thirds (2/3) of the votes cast."**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
18 **overrides the veto of Resolution No. 09-630, "Approving Alternative Council Salary**
19 **Adjustment."**


20 **The foregoing Vetoed Resolution was presented to the Tohono O'odham Legislative Council on the**
21 **22ND. day of DECEMBER, 2009 at a meeting at which a quorum was present, and by a vote of 995.40**
22 **FOR; 1,600.10 AGAINST; -0- NOT VOTING; and [01] ABSENT, failed to pass because it did not receive**
23 **a majority of two-thirds (2/3) [1,730.3] of the votes cast as required by Section 5 of Article VII of the**
24 **Constitution of the Tohono O'Odham Nation.**
