

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving an amendment to the Cooperative Agreement L08AC14165
(formerly AAA080021) between the Tohono O'odham Nation and US Bureau of Land
Management and to expend a \$50,000.00 award from the Bureau of Land Management
for the Solid Waste Management Program FY 2010 BLM budget 11-1102)**

RESOLUTION NO. 09-651

1 **WHEREAS, the Tohono O'odham Nation and the US Bureau of Land Management have entered into**
2 **a Cooperative Agreement # L08AC14165 to fund undocumented migrant trash clean-**
3 **up through December 30, 2012 as stated in the Cooperative Agreement; and**

4 **WHEREAS, this Cooperative Agreement Amendment # 1 to the contract will provide an award of**
5 **\$50,000.00 to the Solid Waste Management Program to be expended by September 30,**
6 **2010; and**

7 **WHEREAS, the Solid Waste Management Program FY2010 BLM Budget 11-1102 has been reviewed**
8 **by the Legislative Natural Resources Committee and the Legislative Budget and**
9 **Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council Accepts and**
11 **approves:**

- 12 **1. The cooperative agreement amendment # 1 to the contract L08AC14165 (formerly**
13 **# AAA080021) between the Tohono O'odham Nation and the US Bureau of Land**
14 **Management.**
- 15 **2. The expenditure of an award of \$50,000.00 from the Bureau of Land Management**
16 **for the Solid Waste Management Program FY 2010 budget 11-1102, to be expended**
17 **by September 30, 2010 in accordance with the budget attached hereto.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation's Officials, to wit: the Chairperson and any designated official are authorized**
20 **to negotiate and execute the agreement, provided however, that any amendments**
21 **affecting the funds or funding levels of the agreement shall be submitted for further**
22 **approval.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day**
24 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595,50 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1 (d)(2)&(3) & (f) of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
