

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sif Oidak Economic Development Initiative Project as a submission
for the Tribal Economic Development Bonds under the American Recovery and
Reinvestment Act of 2009)

RESOLUTION NO. 09-652

1 **WHEREAS, the United States Congress passed the American Recovery and Reinvestment Act in**
2 **February 2009, which permitted Indian tribal governments to issue Tribal Economic**
3 **Development Bonds pursuant to 26 U.S.C. § 7871(f) ; and**

4 **WHEREAS, the Tohono O'odham Legislative Council is authorized to issue revenue bonds for the**
5 **purpose of stimulating commercial and economic development within the boundaries**
6 **of the Tohono O'odham Nation (Tohono O'odham Constitution, Article VI, Section**
7 **1(d)(6)); and**

8 **WHEREAS, Sif Oidak District has conducted a feasibility study in 2007 of a grocery store, fuel**
9 **station, and mechanic shop along Indian Reservation Roads (IRR) 15 within the Sif**
10 **Oidak District boundaries, approximately 6 miles north of the Gu Achi District**
11 **boundary; and**

12 **WHEREAS, the Sif Oidak District Council has approved submitting this economic project for**
13 **Tohono O'odham Legislative Council consideration as a candidate for the Tribal**
14 **Economic Development Bonds (Sif Oidak District Resolution SODC-09-281- Approving**
15 **to Submit the Feasibility Study for the Fuel Station/Mechanic Shop and Convenience**
16 **Store and that it be considered for the Tribal Economic Development Process).**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
18 **authorizes the submission of the Sif Oidak District Project (Fuel Station/Mechanic**
19 **Shop and Convenience Store) as a project for the Tribal Economic Development Bonds**
20 **under the American Recovery and Reinvestment Act of 2009.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials to wit: the Chairman, is hereby**
22 **authorized to submit an application for the Tribal Economic Development Bonds by**
23 **the December 31, 2009, deadline for the Sif Oidak District Project consisting of a Fuel**
24 **Station/Mechanic Shop and Convenience Store.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day**
26 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
27 **AGAINST; 01 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
28 **VI, Section 1 (d)(6) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
