

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Reauthorizing Youth Center Construction Budget and Account to Utilize Reimbursement
Funds in the amount of \$606,025.88 for the Sells Wash Bank Stabilization Project)**

RESOLUTION NO. 09-655

1 **WHEREAS, the Tohono O'odham Nation ("Nation") had obtained funding through the Pima County**
2 **bond election held on May 18, 2004 for construction of a storm water channeling**
3 **system for the Sells Youth Recreation Center in the amount of One Million Five**
4 **Hundred Thousand Dollars (\$1,500,000); and**

5 **WHEREAS, Pima County has transmitted the funds to the Nation on a reimbursable basis under**
6 **the terms of an Intergovernmental Agreement negotiated between Pima County, the**
7 **Pima County Flood Control District, and the Nation in the form attached hereto; and**

8 **WHEREAS, the amount of \$893,511.00 remains and is available to fund the Sells Wash Bank**
9 **Stabilization Project on a reimbursable basis, the Planning Department requests**
10 **approval to use the funds as requested; and**

11 **WHEREAS, the Planning Department has presented a construction budget in the amount of**
12 **\$606,025.88 utilizing reimbursement funds in IGA Account #01-59-T-135623-0704; for**
13 **the Sells Wash Bank Stabilization Project; and**

14 **WHEREAS, all reporting requirements and reimbursement requests will be processed in**
15 **accordance with requirements of the IGA; and**

16 **WHEREAS, the Sells Wash Bank Stabilization Project construction budget has been reviewed by**
17 **the Natural Resources Committee, and the Budget & Finance Committee, which**
18 **recommend approval by the Tohono O'odham Legislative Council.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
20 **approves the 2010 Sells Wash Bank Stabilization Project Budget in the amount of**
21 **\$606,025.88 on a reimbursement basis from the Pima County Flood Control District**
22 **IGA Account #01-59-T-135623-0704.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council approves the attached**
24 **construction budget and hereby authorizes the Chairman and any designated official**
25 **to expend and administer the budget as attached, provided that any amendments**
26 **affecting the funds or funding level shall be submitted for further prior approval by**
27 **the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND Day**
29 **of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
31 **VI, Section 1 (f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
32 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
33 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
34 **Stat. 984).**
