

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Clark Law Firm)

RESOLUTION NO. 09-660

1 WHEREAS, it is advisable that the Human Resources Office has available independent legal
2 representation for employment issues in which the Office of Attorney General is
3 unable to provide legal advise due to conflicts of interest; and

4 WHEREAS, the Human Resources Office recommends an Attorney Contract with The Clark Law
5 Firm to provide legal representation to the Human Resources Office for the foregoing
6 purposes; and

7 WHEREAS, the proposed Attorney Contract is in the amount of \$16,000.00 for the period from
8 October 01, 2009 through September 30, 2010; and

9 WHEREAS, the operating budget for the Human Resources Office (Account No. 01-1005-810) for
10 fiscal year 2010 includes sufficient funds for the Attorney Contract; and

11 WHEREAS, the Domestic Affairs Committee, Human Resources Development Committee and the
12 Budget and Finance Committee recommends approval by the Legislative Council of
13 an attorney contract.

14 NOW, THEREFORE, BE IT RESOLVED that:

- 15 1. The Tohono O'odham Legislative Council hereby approves an attorney contract
16 with the Clark Law Firm in the amount of \$16,000.00 for the Fiscal Year ending
17 September 30, 2010, and in the form attached hereto.
- 18 2. Funding for the Attorney Contract in fiscal year 2010 shall be provided under the
19 operating budget of the Human Resources Office (Account No. 01-1005-810).
- 20 3. The Chairman of the Nation is authorized and directed to execute the Attorney
21 Contract.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND. Day
23 of DECEMBER, 2009 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
24 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article
25 VI, Section 2 (a) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
27 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
