

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sif-Oidak District FY 2009 Mining Royalty Budget)

RESOLUTION NO. 09-141

1 **WHEREAS, the *Sif-Oidak District Council*, approved Resolution No. *09-07-26*, "Approving the FY**
2 **2008 Mining Budget; and**

3 **WHEREAS, the Tohono O'Odham Legislative Council approved Resolution No. *07-647*,**
4 **"Approving the Sif-Oidak District FY 2008 Mining Budget" in the amount of**
5 **\$629,900.00; and**

6 **WHEREAS, *Sif-Oidak District* has a remaining balance in the amount of \$295,897.86 from its FY**
7 **2008 Mining Royalty share of \$925,797.86 under the Nations care; and**

8 **WHEREAS, the *Sif-Oidak District Council* is recommending that the District continue to provide**
9 **services to its District Members under a FY 2009 Mining Budget (October 01, 2008 -**
10 **September 30, 2009); and**

11 **WHEREAS, an expenditure report for the *Sif-Oidak District* FY 2008 Mining Budget shows a**
12 **remaining balance for the budget in the amount of \$110,550.28; and**

13 **WHEREAS, the *Sif-Oidak District Finance Committee* has recommended that its FY 2008 balance**
14 **of Mining Royalty under the Nation's care in the amount of \$295,897.86, the surplus**
15 **of \$110,550.28 for FY 2008 Mining Royalty Carryover and \$123,551.86 out of the**
16 **District's Housing Investment Account be used to fund the FY 2009 Mining Budget in**
17 **the amount of \$530,000.00.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **Sif-Oidak District FY 2009 Mining Royalty Budget in the amount of \$530,000.00 with**
20 **\$110,550.28 coming from FY 2008 Mining Royalty Carryover, \$295,897.86 coming**
21 **from the balance of FY 2008 Mining Royalty under the Tohono O'odham Nation's care**
22 **and \$123,551.86 coming from the District's Housing Investment Account.**

23 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves *Sif-Oidak***
24 ***Districts* request to transfer of \$123,551.86 from its Wachovia Housing Investment**
25 **Account to its Operating Account to be expended for this purpose.**

26 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council directs the Tohono**
27 **O'odham Nation Treasury to transfer the remainder of \$295,897.86 to the Districts**
28 **Wachovia Account for expenditures for said Budget.**

29 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**
30 **attached Budget shall be submitted for further prior approval by the Tohono**
31 **O'odham Legislative Council.**
