(Approving and Appropriating the FY 2011 Supplemental Budget for the Department of
Natural Resources-Livestock Inspector Program in the amount of \$69,608.00 for a
total budget of \$298,325.74)

RESOLUTION NO. 11-013

1 **WHEREAS, the Department of Natural Resources-Livestock Inspector Program is a key program**
2 **of the Nation, it's duties to inspect livestock; and**

3 **WHEREAS, its program's vehicles have taken a pounding over the last 11 years because of usage**
4 **on rough dirt roads, high mileage and for employee safety; and**

5 **WHEREAS, the Department and Executive Office have determined it necessary to provide added**
6 **supplemental funding to the Department of Natural Resources-Livestock Inspector's**
7 **Program to improve the overall department and delivery of services to our Nation's**
8 **members; and**

9 **WHEREAS, the Tohono O'odham Legislative Council Approved the Department of Natural**
10 **Resources-Livestock Inspector FY11 budget 01-1501 by resolution 10-295 in the**
11 **amount of \$228,717.74; and**

12 **WHEREAS, the Department of Natural Resources-Livestock Inspector is requesting the approval**
13 **by Budget Amendment No. 1 to account number 01-1501 to appropriate supplemental**
14 **funds in the amount of \$69,608.00 for a total revised budget of \$298,325.74; and**

15 **WHEREAS, Department of Natural Resources-Livestock Inspector Program is requesting that the**
16 **additional funding be used to purchase capital equipment, two work trucks for**
17 **livestock inspection purposes and the applicable required insurance; and**

18 **WHEREAS, the allocated supplemental funds is a one-time allocation for Fiscal Year 2011; and**

19 **WHEREAS, budget amendment No. 1 to FY 2011 account 01-1501 has been reviewed and**
20 **recommend approval by the Legislative Agricultural and Budget & Finance**
21 **Committees of the Tohono O'odham Legislative Council; and**

22 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby approves**
23 **budget amendment No. 1 to the Department of Natural Resources-Livestock**
24 **Inspector FY 2011 account 01-1501 for:**

- 25 **1. Appropriate supplemental funding in the amount of \$69,608.00 for a total revised**
26 **budget of \$298,325.74.**
- 27 **2. To create new line item 750, Capital Equipment, to purchase two work trucks for**
28 **the purposes of inspecting Nation's livestock and applicable insurance with the**
29 **budget attached hereto.**
- 30 **3. The supplemental funding is a one-time allocation and funds will be utilized**
31 **during the FY2011.**

5 **Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
7 **of [JANUARY, 2011] at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
9 **VI, Section 1(d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
10 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**




