

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Budget Amendment #1 of Account No. 01-1094 to Reflect a Fifty Percent Cost Share Match for the FY2010 Emergency Management Performance Grant through the Arizona Division of Emergency Management)

RESOLUTION NO. 11-014

1 **WHEREAS, the United States Department of Homeland Security, Federal Emergency**
2 **Management Agency has distributed grants to counties, through their respective**
3 **states, to fund equipment purchases, training and personnel costs by departments**
4 **that provide emergency management services within their respective jurisdictions;**
5 **and**

6 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
7 **requiring a fifty percent (50%) cost share match from the tribe as a sub-grantee; and**

8 **WHEREAS, the Tohono O'odham Nation Office of Emergency Management has received a grant**
9 **award of the FY2010 Emergency Management Performance Grant program through**
10 **the State of Arizona in the amount of \$20,000.00; and**

11 **WHEREAS, the Tohono O'odham Nation Office of Emergency Management requires changes to**
12 **its FY2011 Budget Account 01-1094 in order to reflect the fifty percent (50%) cost share**
13 **match for the grant; and**

14 **WHEREAS, the FY2010 EMPG grant award of \$20,000.00, Grant number 2010-EP-EX-0034, has**
15 **been accepted by resolution of the Tohono O'odham Legislative Council; and**

16 **WHEREAS, the FY2011 Budget Account 01-1094 was appropriately changed to reflect no monetary**
17 **funding level changes but only changes within the appropriate Budget Narrative to**
18 **reflect the fifty percent (50%) cost share match for the grant; and**

19 **WHEREAS, the Amendment #1 of the Office of Emergency Management's FY2011 Budget Account**
20 **#01-1094 has been reviewed by the Budget Office, Executive Office, Domestic Affairs**
21 **Committee and Budget & Finance Committee, of which all recommend acceptance**
22 **of the budget amendment by the Legislative Council.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
24 **accepts the Budget Amendment #1 of the Office of Emergency Management FY2011**
25 **Budget Account #01-1094 to reflect no monetary change in the funding level and**
26 **reflect the fifty percent (50%) cost share match within the Budget Narrative of the**
27 **appropriate line items for the FY2010 Emergency Management Performance Grant.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
29 **Chairperson and any designated official to expend and administer the budget as**
30 **attached, provided that any amendments affecting the funds or funding level shall**
31 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**


