

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Letter of Offer & Acceptance with the Arizona Department of Emergency & Military Affairs and the FY2010 Emergency Management Performance Grant No. 2010-EP-EX-0034 in the Amount of \$20,000.00)

RESOLUTION NO. 11-015

1 **WHEREAS, the United States Department of Homeland Security, Federal Emergency**
2 **Management Agency has distributed grants to counties, through their respective**
3 **states, to fund equipment purchases, training and personnel costs by departments**
4 **that provide emergency management services within their respective jurisdictions;**
5 **and**

6 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
7 **requiring the tribe to sign a Letter of Offer and Acceptance with the state; and**

8 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer & Acceptance with the**
9 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**
10 **Department of Homeland Security, Federal Emergency Management Agency,**
11 **Emergency Management Performance Grant (EMPG) program on a reimbursement**
12 **basis to finance emergency management related costs; and**

13 **WHEREAS, the Tohono O'odham Nation has received Grant Award No. 2010-EP-EX-0034 of the**
14 **FY2010 EMPG program through the State of Arizona in the amount of \$20,000.00 for**
15 **the Office of Emergency Management; and**

16 **WHEREAS, the Letter of Offer & Acceptance and the FY2010 EMPG grant award has been reviewed**
17 **by the Office of Attorney General, the Office of Grants & Contracts, Budget Office,**
18 **Executive Office, Domestic Affairs Committee and Budget & Finance Committee, of**
19 **which all recommend acceptance of the budget amendment by the Legislative**
20 **Council.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
22 **accepts the Letter of Offer & Acceptance with the Arizona Department of Emergency**
23 **& Military Affairs and the FY2010 EMPG Grant Award No. 2010-EP-EX-0034 in the**
24 **amount of \$20,000.00 on a reimbursement basis from the Tohono O'odham Nation**
25 **General Fund for enhancing the Tohono O'odham Nation Office of Emergency**
26 **Management and further waives any additional indirect costs to administer this**
27 **grant.**

28 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation, Office of Emergency Management**
29 **is authorized to expend funds from this grant in the amount of \$20,000.00 in**
30 **accordance with the terms of the FY2010 EMPG grant program from October 1, 2010**
31 **to June 30, 2011.**



5 **for further prior approval.**


6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
7 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
9 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
10 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**
