

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Acceptance of the Arizona Department of Homeland Security, 2010 State Homeland Security Grant Award 777418-01 in the Amount of \$32,771.00)**

**RESOLUTION NO. 11-017**

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**  
2 **counties, through their respective states, to fund equipment purchases, personnel**  
3 **and training by departments that provide public safety services within their**  
4 **respective jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**  
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**  
8 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**  
9 **Department of Homeland Security, Federal Emergency Management Agency, on a**  
10 **reimbursement basis to finance Homeland Security initiatives; and**

11 **WHEREAS, the Letter of Offer and Acceptance was approved in the form attached hereto by the**  
12 **Tohono O'odham Legislative Council through Resolution 09-256 signed by the**  
13 **Chairman; and**

14 **WHEREAS the Tohono O'odham Nation has been awarded a grant from the Arizona Department**  
15 **of Homeland Security in the amount of \$32,771.00 as part of the 2010 State Homeland**  
16 **Security Program Grant No. 777418-01 for the continuing the Homeland Security**  
17 **Initiative Planning Position for the Office of Emergency Management; and**

18 **WHEREAS, the 2010 State Homeland Security Program Grant No. 777418-01 award of \$32,771.00**  
19 **has been reviewed by the Office of Grants & Contracts, Executive Office, Domestic**  
20 **Affairs Committee and Budget & Finance Committee, of which all recommend**  
21 **acceptance of the grant award by the Legislative Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
23 **accepts the grant award of \$32,771.00 on a reimbursement basis from the Tohono**  
24 **O'odham Nation General Fund for continuing the Homeland Security Initiative**  
25 **Planning position and further waives any additional indirect costs to administer this**  
26 **grant.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Office of Emergency Management is**  
28 **authorized to expend funds from this grant in the amount of \$32,771.00 in**  
29 **accordance with the terms of the 2010 State Homeland Security Program Grant No.**  
30 **777418-01 from May 1, 2011 to September 30, 2011.**

4 amendments affecting the funding or funding levels of the grant shall be submitted  
5 for further prior approval.


6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day  
7 of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-  
8 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article  
9 VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
10 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
11 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
12 Stat. 984).
