

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the Arizona Department of Homeland Security, 2010 State Homeland Security Grant Award 777907-02 in the Amount of \$33,666.00)

RESOLUTION NO. 11-018

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **counties, through their respective states, to fund equipment purchases, personnel**
3 **and training by departments that provide public safety services within their**
4 **respective jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
6 **requiring tribes to sign a Letter of Offer and Acceptance; and**

7 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**
8 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**
9 **Department of Homeland Security, Federal Emergency Management Agency, on a**
10 **reimbursement basis to finance Homeland Security initiatives; and**

11 **WHEREAS, the Letter of Offer and Acceptance was approved in the form attached hereto by the**
12 **Tohono O'odham Legislative Council through Resolution 09-256 signed by the**
13 **Chairman; and**

14 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the Arizona Department**
15 **Of Homeland Security in the amount of \$33,666.00 as part of the 2010 State Homeland**
16 **Security Program Grant No. 777907-02 for the enhancement of the Emergency**
17 **Operations Center for the Office of Emergency Management; and**

18 **WHEREAS, the 2010 State Homeland Security Program Grant No. 777907-02 award of \$33,666.00**
19 **has been reviewed by the Office of Grants & Contracts, Executive Office, Domestic**
20 **Affairs Committee and Budget & Finance Committee, of which all recommend**
21 **acceptance of the grant award by the Legislative Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
23 **accepts the grant award of \$33,666.00 on a reimbursement basis from the Tohono**
24 **O'odham Nation General Fund for the enhancement of the Emergency Operations**
25 **Center and further waives any additional indirect costs to administer this grant.**

26 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Office of Emergency Management is**
27 **authorized to expend funds from this grant in accordance with the terms of the 2010**
28 **State Homeland Security Program Grant No. 777907-02 from October 1, 2010 to**
29 **September 30, 2011.**

4 **amendments affecting the funding or funding levels of the grant shall be submitted**
5 **for further prior approval.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
7 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
9 **VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
10 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
11 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
12 **Stat. 984).**




