LEGISLATIVE ORDER NO. 11-022

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to**
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**
3 **and special committees." (Constitution of the Tohono O'odham Nation, Article VI,**
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**
6 **the authority to "by majority vote, call for a special session." (Legislative Rules of the**
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**


8 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**
9 **the authority to by majority vote "hold a session in some location other than the**
10 **chambers located at Sells." (Legislative Rules of the Tohono O'odham Legislative**
11 **Council, Article I, Section 2.C.1.); and**

12 **WHEREAS, the Domestic Affairs Committee requests a January 31, 2011 special session at 1:00**
13 **p.m. at the Libby Army Airfield in Sierra Vista, Arizona for a presentation and tour of**
14 **the U.S. Department of Homeland Security Customs and Border Protection's**
15 **Unmanned Aircraft Systems Program.**

16 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**
17 **January 31, 2011 special session at 1:00 p.m. at the Libby Army Airfield in Sierra Vista,**
18 **Arizona for a presentation and tour of the U.S. Department of Homeland Security**
19 **Customs and Border Protection's Unmanned Aircraft Systems Program.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH day of**
21 **JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,411.0 FOR; -0- AGAINST;**
22 **184.50 [01] NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section**
23 **1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
26 **Stat. 984).**
