

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY11 CCDF Discretionary Funds, Budget Amendment #1,
Account 11-1201)

RESOLUTION NO. 11-023

1 **WHEREAS, the Tohono O'odham Nation through the Child Care & Development Fund has been**
2 **successfully providing services and assistance to eligible Tohono O'odham children**
3 **and families; and**

4 **WHEREAS, the original FY10 Discretionary Funds Budget was based on the previous years'**
5 **budget, and this Amendment #1 reflects an increase in the amount of \$54,737.00, as**
6 **reflected in the FY10 Final Grant Award Notice for Discretionary Funds in the amount**
7 **of \$384,802.00; and**

8 **WHEREAS, the FY11 CCDF Discretionary Funds, Budget Amendment #1, Account 11-1201 includes**
9 **the addition of the following line items: 722 Program Supplies in the amount of**
10 **\$13,000.00; 723 Uniforms in the amount of \$4,000.00; and 816 Child Care Certificates**
11 **in the amount of \$34,973.48; and**

12 **WHEREAS, the FY11 Discretionary Funds, Budget Amendment #1, Account 11-1201 has been**
13 **reviewed and approved by the Human Resources Development Committee and the**
14 **Budget and Finance Committee.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve the Child Care & Development Fund FY11 Discretionary Funds, Budget**
17 **Amendment #1 Account 11-1201 by increasing the budget from \$330,065.00 to**
18 **\$384,802.00 an increase of \$54,737.00; which includes the addition of line items: 722**
19 **Program Supplies in the amount of \$13,000.00; 723 Uniforms in the amount of**
20 **\$4,000.00; and 816 Child Care Certificates in the amount of \$34,973.48.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation's Officials, to wit; the Chairperson and any designated official are authorized**
23 **to negotiate and expend the budget, provided however, that any amendments**
24 **affecting the funds or funding levels of the budget shall be submitted for further prior**
25 **approval.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
27 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
29 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
32 **Stat. 984).**
