

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY11 CCDF Mandatory Funds, Budget Modification/Amendment #1,
Account 11-1202)

RESOLUTION NO. 11-024

1 **WHEREAS, the Tohono O'odham Nation through the Child Care & Development Fund has been**
2 **successfully providing services and assistance to eligible Tohono O'odham children**
3 **and families; and**

4 **WHEREAS, the original FY10 Mandatory Funds Budget was based on the FY09 Budget, and this**
5 **Modification/Amendment #1 reflects a decrease in line item 850 Food and indirect**
6 **cost of \$6,874.65, and an increase to total budget by \$75,929.00 to \$649,623.00, as**
7 **reflected in the FY10 Grant Award Notice for Mandatory Funds in the amount of**
8 **\$649,623.00; and**

9 **WHEREAS, the FY11 CCDF Mandatory Funds, Budget Modification/Amendment #1, Account 11-**
10 **1202 has been reviewed and approved by the Human Resources Development**
11 **Committee and Budget and Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Child Care & Development Fund FY11 Mandatory Funds, Budget**
14 **Modification/Amendment #1 Account 11-1202, which reflects a decrease in line item**
15 **850 Food and indirect cost of \$6,874.65, and an increase to the total budget by**
16 **\$75,929.00 from \$573,694.00 to \$649,623.00, to reflect the FY10 Grant Award Notice for**
17 **Mandatory Funds in the amount of \$649,623.00.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation's Officials, to wit; the Chairperson and any designated official are authorized**
20 **to negotiate and expend the budget, provided however, that any amendments**
21 **affecting the funds or funding levels of the budget shall be submitted for further prior**
22 **approval.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
24 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1 (d)(2)(3) & (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
