

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 3 to the Agreement for the Incarceration of Prisoners with
the Gallup McKinley Adult Detention Center/Jail Authority Board)

RESOLUTION NO. 11-025

1 **WHEREAS, the Tohono O'odham Nation previously entered into an Agreement for the**
2 **incarceration of prisoners with Gallup McKinley Adult Detention Center/Jail**
3 **Authority Board to house inmates from the Tohono O'odham Detention Center**
4 **("Agreement"); and**

5 **WHEREAS, this inmate housing arrangement was necessary to deal with disruptive inmates and**
6 **general overcrowding in the Tohono O'odham Detention Center; and**

7 **WHEREAS, the Tohono O'odham Corrections Program continues to require the use of bed space**
8 **at the Gallup McKinley Adult Detention Center; and**

9 **WHEREAS, the Agreement has been amended twice before to extend the term of the Agreement;**
10 **and**

11 **WHEREAS, Amendment No. 3 has been reviewed by the Domestic Affairs Committee, which**
12 **recommends approval of Amendment No. 3 by the Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED the current Agreement expires on September 30, 2010 and an**
14 **amendment is required to extend the term of the Agreement through September 30,**
15 **2011, as set forth in the attached Amendment No. 3; which is retroactive to October**
16 **01, 2010 and that the Tohono O'odham Legislative Council hereby approves**
17 **Amendment No. 3 to the Agreement for the Incarceration of Prisoners By and**
18 **Between Tohono O'odham Nation and Gallup McKinley Adult Detention Center/Jail**
19 **Authority Board substantially in the form attached hereto, and authorizes the**
20 **Chairman of the Nation to execute it and any further amendments extending the term**
21 **of the Agreement.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
23 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 174.50[05] ABSENT, pursuant to the powers vested in the Council**
25 **by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
