

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with the Law Firm of Yoder & Langford, P.C.)

RESOLUTION NO. 11-028

1 **WHEREAS, by Resolution No. 10-427, the Nation approved an Attorney Contract in the amount of**
2 **\$20,000 with the law firm of Yoder & Langford, P.C.; and**

3 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**
4 **Contract, which adds \$10,000 to the budget for the Attorney Contract for a new budget**
5 **of \$30,000; and**

6 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment**
7 **No. 1 to the Attorney Contract and recommend approval by the Legislative Council.**

8 **NOW, THEREFORE, BE IT RESOLVED that:**

9 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to**
10 **the Attorney Contract with the law firm of Yoder & Langford, P.C., which adds**
11 **\$10,000 to the budget for the Attorney Contract, substantially in the form**
12 **attached hereto.**

13 **2. The Chairperson of the Nation is authorized and directed to execute Amendment**
14 **No. 1 to the Attorney Contract with the law firm of Yoder & Langford.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day**
16 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**
18 **VI, Section 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
