**RESOLUTION NO. 11-029**

1 **WHEREAS, the Gu-Vo District did bring forth the Gu-Vo District Administration's Budget**  
2 **Modification No. 1 for the Fiscal Year 2011 Budget; and**

3 **WHEREAS, the Gu-Vo District Administration is requesting modification/amendment in their**  
4 **FY' 2011 Budget, 612 Occasional Appointment due to line item is depleting; and**

5 **WHEREAS, the proposed amendment from the Gu-Vo District Administration has gone through**  
6 **proper reviews from the Gu-Vo District and the Tohono O'odham Legislative Budget**  
7 **and Finance Committee; and**

8 **WHEREAS, it is the recommendation of the Budget & Finance Committee to approve Modification**  
9 **#1 for the Gu-Vo District Administration budget modification/amendment.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
11 **the Budget Modification/Amendment #1 for the Gu-Vo District Administration,**  
12 **increasing line item 612 Occasional Appointment in the amount of \$6,000.00, line**  
13 **item 852 Donation/Contribution and 865 Emergency Assistance have both been**  
14 **decreased in the amount of \$3,000.00.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairman and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendment affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> Day**  
20 **of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article**  
22 **VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
