

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Legislative Branch FY 2011 Budget Modification/Amendment No. 1)**

RESOLUTION NO. 11-030

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**
4 **funds shall be pursuant to appropriations or budgets" authorized by resolution or**
5 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2));**
6 **and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**
8 **2011 Budget Modification/Amendment No. 1 in the amount of \$28,000.00 to provide**
9 **for additional personnel and operational expenses in line items 612 Occasional**
10 **Appointment, 640 Committee Fees, 711 Communication Expenses, 810 Professional**
11 **Services, and 812 Public Relations, and which is incorporated by this reference; and**

12 **WHEREAS, the proposed budget modification/amendment transfers funds among existing line**
13 **items and does not change the approved FY 2011 Legislative Branch budget amount**
14 **of \$3,269,563.62; and**

15 **WHEREAS, there are sufficient funds in the Legislative Branch FY 2011 budget to support the**
16 **proposed Legislative Branch FY 2011 Budget Modification/Amendment No. 1; and**

17 **WHEREAS, the Legislative Branch FY 2011 Budget Modification/Amendment No. 1 has been**
18 **reviewed by the Budget and Finance Committee.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
20 **approves the Legislative Branch FY 2011 Budget Modification/Amendment No. 1 in**
21 **the amount of \$28,000.00 as follows:**

- 22 1. **increase line item 612 Occasional Appointment by \$5,000.**
- 23 2. **increase line item 640 Committee Fees by \$3,000.**
- 24 3. **increase line item 711 Communication Expenses by \$10,000.**
- 25 4. **increase line item 810 Professional Services by \$5,000.**
- 26 5. **increase line item 812 Public Relations by \$5,000.**
- 27 6. **decrease line items 720 Supplies-Office by \$5,000.**
- 28 7. **decrease line item 721 Supplies-Other by \$5,000.**
- 29 8. **decrease line item 771 RM Vehicles by \$5,000.**
- 30 9. **decrease line item 774 Computer Maintenance by \$10,000.**
- 31 10. **decrease line item 750 Major Capital by \$3,000.**

1 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the
2 Legislative Council Chairperson and Vice-Chairperson to administer and expend the
3 attached budget, provided however, that any amendments affecting the funds or
4 funding levels shall be submitted for further prior approval by the Tohono O'odham
5 Legislative Council.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST Day
7 of JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-
8 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article
9 VI, Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
10 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
11 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
12 Stat. 984).


