

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting January 24, 2011 Special Session to Address FICA Issues)**

**LEGISLATIVE ORDER NO. 11-031**

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O’odham Council, standing committees, boards**  
3 **and special committees.” (Constitution of the Tohono O’odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O’odham Legislative Council vests the Council with**  
6 **the authority to “by majority vote, call for a special session” (Legislative Rules of the**  
7 **Tohono O’odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Legislative Council Budget and Finance Committee has requested that a special**  
9 **session be set for January 24, 2011 at 9:00 a.m. to address FICA issues.**

10 **NOW, THEREFORE, BE IT ORDERED that the Tohono O’odham Legislative Council hereby sets a**  
11 **Special Session for January 24, 2011 at 9:00 a.m. to address FICA issues.**

12 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 21<sup>ST</sup> day of**  
13 **JANUARY, 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**  
14 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section**  
15 **1 (a) of Article VI of the Constitution of the Tohono O’odham Nation, adopted by the Tohono**  
16 **O’odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
18 **Stat. 984).**
