

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amend Enrollment Resolution No. 99-633)

RESOLUTION NO. 11-035

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "enact laws and**
2 **ordinances for governing the enrollment and adoption of members and the**
3 **relinquishment and loss of membership" Constitution of the Tohono O'odham Nation**
4 **Article VI Section 1(h); and**

5 **WHEREAS, Article VIII Section 1 of the Enrollment Ordinance No. 5-81 (as amended) provides that**
6 **the Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption; and**

8 **WHEREAS, on June 8, 1999 the Legislative Council pursuant to Resolution No. 99-311, approved**
9 **Aaliyah R. Moreno Roll No. 4347-S-99 for membership in the Tohono O'odham Nation;**
10 **and**

11 **WHEREAS, on December 6, 1999 the Legislative Council pursuant to Resolution No. 99-633**
12 **approved Aaliyah R. Moreno Roll No. 4435-S-99 for membership in the Tohono**
13 **O'odham Nation; and**

14 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth,**
15 **and family tree, Aaliyah R. Moreno listed with Roll No. 4347-S-99 and 4435-S-99 is the**
16 **same individual; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Applications*) provides that once a number**
18 **has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 22 **1. The Tohono O'odham Legislative Council amends Resolution No. 99-633 as follows:**
23 **The Roll No. listed for Aaliyah R. Moreno shall retain Roll No. 4347-S-99 to reflect**
24 **the number originally assigned to the application of Aaliyah R. Moreno on June 8,**
25 **1999 which was approved by this Council pursuant to Resolution No. 99-311 and**
26 **Amend Resolution 99-633 that the name Aaliyah R. Moreno Roll No. 4435-S-99 shall**
27 **be removed.**
- 28 **2. The Enrollment Committee shall make the necessary changes in the records of the**
29 **Enrollment Office to incorporate the stated amendment.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
31 **of FEBRUARY 2011 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article**
33 **VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
34 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
35 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
36 **Stat. 984).**
