#2 in the amount of \$114,081.07 October 1, 2010 – September 30, 2011)

RESOLUTION NO. 11-046

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Program for Indians**
2 **Cardiovascular Risk Reduction Demonstration Project grant through FY 2011 with a**
3 **carry-over budget amount of \$114,081.07; and**

4 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**
5 **establishment of the Cardiovascular Risk Reduction Demonstration Project, funded**
6 **by the Special Diabetes Programs for Indians, authorized by the Balanced Budget Act**
7 **of 1997; and**

8 **WHEREAS, Resolution No. 10-437 of the Tohono O'odham Legislative Council has rescinded**
9 **Resolution No. 10-315 and approved the Cardiovascular Risk Reduction**
10 **Demonstration Project budget in the amount of \$106,603.00 for FY 2011 estimated no-**
11 **cost carryover; and**

12 **WHEREAS, the HOPP CVD has prepared Budget Amendment No. 2 to incorporate the final**
13 **carryover balance to bring the No-Cost Extension amount to \$114,081.07 to close out**
14 **the grant.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
16 **and authorized the expenditure of the FY 2011 HOPP CVD Budget Amendment No. 2**
17 **from \$106,603.00 to \$114,081.07, hereby attached.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget as**
20 **attached, provided that any amendments affecting the funds or funding level shall be**
21 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
23 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 174.50[06] ABSENT, pursuant to the powers vested in the Council**
25 **by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
