

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Tohono O'odham Legislative Council Calendar June 2010 - June 2011)**

LEGISLATIVE ORDER NO. 11-047

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant to**
3 **Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Legislative Council has adopted Legislative Rules requiring that "Prior to an**
5 **official adjournment, the Legislative Council shall adopt a legislative calendar which**
6 **shall commence on the first working day of June on which the Legislative Council shall**
7 **be called into Legislative Session. (Legislative Rules of the Tohono O'odham**
8 **Legislative Council, Article I, Section 1.A.1); and**

9 **WHEREAS, the Tohono O'odham Legislative Rules Committee recommended and the Legislative**
10 **Council adopted a Legislative Council Calendar for the 2010-2011 Legislative Session**
11 **(Legislative Order No. 10-181); and**

12 **WHEREAS, the Rules Committee has recommended amendments to the Calendar as reflected in**
13 **the "Tohono O'odham Legislative Council Calendar June 2010- June 2011 (Amended),"**
14 **which is incorporated by this reference.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**
16 **adopts the Tohono O'odham Legislative Council Calendar June 2010 - June 2011**
17 **(Amended).**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08TH day of**
19 **FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 1,650.40 FOR; 770.60**
20 **AGAINST; -0-NOT VOTING; and 174.50[07] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**
