

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Adopting Tohono O'odham Legislative Council Calendar June 2011 - June 2012)**

**LEGISLATIVE ORDER NO. 11-048**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "establish rules**  
2 **and procedures to regulate all meetings of the Tohono O'odham Council" pursuant to**  
3 **Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation; and**

4 **WHEREAS, the Legislative Council has adopted Legislative Rules requiring that:**

5 **Prior to an official adjournment, the Legislative Council shall adopt a legislative**  
6 **calendar which shall commence on the first working day of June on which the**  
7 **Legislative Council shall be called into legislative session; provided that, in a**  
8 **general election year, the legislative calendar shall commence on the first**  
9 **Monday in June that is at least ten days after the Election Board is required to**  
10 **issue its Certificate of Election Results pursuant to Article VII, Section 6(K) of the**  
11 **Uniform Election Ordinance.**

12 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section 1(A)(1));**  
13 **and**

14 **WHEREAS, the Uniform Election Ordinance provides a longer time frame within which the**  
15 **Council may convene in general session following a general election (Uniform Election**  
16 **Ordinance, Ordinance No. 03-86, Article VII, Section 6(N), 12 T.O.C. Chapter 1 and**  
17 **<http://tolc-nsn.org/docs/Title12Ch1.pdf>); and**

18 **WHEREAS, the Tohono O'odham Legislative Rules Committee has developed a "Tohono O'odham**  
19 **Legislative Council Calendar June 2011 - June 2012" and recommends its adoption.**

20 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it**

21 **(1) adopts the "Tohono O'odham Legislative Council Calendar June 2011 - June 2012;**  
22 **and**

23 **(2) suspends Legislative Rules Article I, Section 1(A)(1) for the limited purpose of**  
24 **allowing the maximum time permitted by the Uniform Election Ordinance for**  
25 **convening the June 2011 general session.**

26 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of**  
27 **FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 1,650.40 FOR; 770.60**  
28 **AGAINST; [02] NOT VOTING; and 174.50[07] ABSENT, pursuant to the powers vested in the Council**  
29 **by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the**  
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**
