

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Health and Human Services, Senior Services
Division, Title III Application for FY2011-2015)

RESOLUTION NO. 11-057

1 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services, Division of**
2 **Senior Services has provided and continues to provide elder services to the Tohono**
3 **O'odham elders of the Nation; and**

4 **WHEREAS, the Tohono O'odham Nation, Department of Health and Human Services, Senior**
5 **Services Division is committed to obtaining services for its members which will**
6 **improve living conditions for its elder members; and**

7 **WHEREAS, by Resolution Number 10-1414 the Tohono O'odham Legislative Council approved the**
8 **FY2011 budgets for: Title IIIB - \$27,961.00; C-1 - \$87,420.00; C-2 - \$42,845.00 to continue**
9 **nutrition, socialization and transportation services to eligible elders. Title III E -**
10 **\$32,443.00 to continue to provide support services to current and potential caregivers**
11 **who provide care services for elders and to elders who care for grandchildren. Title**
12 **III Nutrition Incentive Program -\$7,219.00, and a recurring State funds budget for**
13 **\$20,737.00 to support Title III B, Title III C-1 and Title III C-2 for congregate meals,**
14 **home delivered meals and transportation services; and**

15 **WHEREAS, the total budget amount for FY2011 is \$218,625.00; and**

16 **WHEREAS, the Tohono O'odham Nation will continue to participate in the Older Americans Act,**
17 **Title III for the grant period FY 2011-2015 (July 01, 2010 to June 30, 2015); and**

18 **WHEREAS, the Inter-Tribal Council of Arizona (ITCA) Area Agency on Aging will reimburse the**
19 **Tohono O'odham Nation for allowable costs incurred for participating in this grant.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **Title III Older Americans Act grant application for the period of FY 2011-2015 (July 01,**
22 **2010 through June 30, 2015) and authorizes matching funds of 10 percent for the Title**
23 **III grant.**

24 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the Tohono**
25 **O'odham Health and Human Services, Division of Senior Services, Elderly Services**
26 **Program to share consumer data with ITCA for the purpose of program reporting. The**
27 **ITCA will not share client specific information with other agencies unless prior**
28 **approval is obtained from the Tohono O'odham Nation.**

1 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council designates the Senior**
2 **Services Program Manager to be responsible for the activities of the Elderly Services**
3 **Program.**

4 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-**
5 **Chairman and any designated officials are hereby authorized to negotiate and execute**
6 **the grant application provided however, that any amendment affecting the funding**
7 **or funding levels of this grant application shall be submitted for further prior**
8 **approval by this Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
10 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,216.30 FOR; -0-**
11 **AGAINST; -02- NOT VOTING; and 379.20[06] ABSENT, pursuant to the powers vested in the Council**
12 **by Article VI, Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted**
13 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
14 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
15 **18, 1934 (48 Stat. 984).**
