1 **WHEREAS, the Legislative Council reviewed the Pisinemo District FY 2009 F-16 Damage Claims**  
2 **Carryover Budget; and**

3 **WHEREAS, the Legislative Council was provided information on balances remaining within the**  
4 **FY 2009 F-16 Damages Claims Budget; and**

5 **WHEREAS, the remaining balance of \$16,862.89 will assist the Pisinemo District to continue**  
6 **providing much needed services and assistance for its District members; and**

7 **WHEREAS, the Pisinemo District Administration has submitted a budget proposal to carryover**  
8 **the remaining \$16,862.89 of the F16 Damages Claim Budget.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council approves the request of Pisinemo**  
10 **District to carry over its FY 2009 F-16 Damages Claim Budget in the amount of**  
11 **\$16,862.89.**

12 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby**  
13 **authorizes the Chairperson and any designated official to expend and administer the**  
14 **budget as attached, provided that any amendments affecting the funds or funding**  
15 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**  
16 **Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
18 **of FEBRUARY, 2011 at a meeting at which a quorum was present with a vote of 2,421.0 FOR; -0-**  
19 **AGAINST; -0- NOT VOTING; and 174.50[03] ABSENT, pursuant to the powers vested in the Council**  
20 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
21 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**
